**Rules:**

1. New York State Catholic Daughters will award three (3) \$1,000.00 scholarships to a daughter, son or dependent of a member of a NYS Catholic Daughter Court.
2. The member must belong to a court for **two years** or **be a charter member** and be a member in good standing and attend a minimum of three (3) business meetings in the current court year.
3. The candidate for scholarship must be a graduate from High School for the term ending June 2018.
4. Each application must be filled in completely and submitted with five (5) attachments **POST MARKED NO LATER THAN MAY 1, 2018**
  - a. Copy of letter of acceptance
  - b. Letter from applicant's Pastor
  - c. Transcript of applicant's High School Record
  - d. Family financial status – Page 1 of current 2017 Federal Income Tax Return
  - e. Applicant essay of 150-200 words telling something about themselves and their future plans.
  - f. Letter of acceptance from college/nursing school
5. Each application must be verified by the **COURT REGENT**.

All scholarships will be awarded on the basis of scholastic achievement, financial need and the applicant's essay.
